Don't be afraid to tell us all about your housing situation. Our advisers want to be able to advise you fully and treat everything you say in strictest confidence.

What we do locally

We provide advice and specialist help for those with a housing or housing related problem. We deal with clients who are eligible for advice under Legal Aid rules, both certificated and Legal Help cases; but also offer a service, subject to capacity, to those who are not eligible for Legal Aid. We also run a court desk service on possession hearings at Plymouth Combined Courts, Torquay and Newton Abbot County Court, and Barnstaple County Court.
